2.	It is unlawful to consume alcoholic beverages in county parks, except by permit from Recreation, Parks & Community Services (RP&CS). For further information regarding a permit for alcohol use, contact the RP&CS.			
3.	Parks hours are from sunrise to sunset. Users must be out of the Park, by dark, unless special permission is granted, in writing, by the Department of RP&CS.		special permission	
4.	Overnight parking or camping is not allowed u	nless specifically authorized in writing f	rom RP&CS.	
5.	Where grills are available, please extinguish all charcoal fires before leaving the park. ABSOLUTELY NO OPEN CAMP FIRES!			
6.	Medical Insurance is not provided. No lifegua	ards are on duty at Elms Beach, Myrtle I	Point Park, or any	

other County beachfront parks. Usage of these waters may be dangerous and is at your own risk.
