The Battle is Joined

Sunday October 23, 2005 was a nicer day than the last couple of days. This was good considering I had planned a three-hour workday at the park. Earlier in the month, Mary Piotrowski and I started the assault on the multiflora rose infesting the parking lot edges. Our two-hour effort cleared out a 20 by 20 patch and revealed several small trees and shrubs.

I had not heard from anyone about joining me Sunday, so I was pleasantly surprised to have two vehicles waiting when I arrived. Robert Willey and Mollie Quinn were my work crew for the day. We grabbed our chosen tools of destruction and began our assault.

And considering that the rose is well armed itself with lots of thorns, it was a battle. Mollie and I concentrated on expanding the original area, while Robert worked on opening up the new section. Pulling down the overhead branches was the bulk of work on our original section. We found the multiflora rose entwining itself with the Japanese honeysuckle forming a dense sun tight covering. Not as pervasive, but still doing well was the grape vine bearing lots of fruit.

Robert was able to find the base of several immense multiflora rose plants. These monsters had stalks as thick as small trees and easily the size of a large shrub. Five or six of the behemoths were stacked near the recycling bin.

We removed all rose hips we could find on the plants. These were placed in a black bag to be disposed of separately. The remaining debris can be composted without worry of spreading the park's problem to other locations. Rose hips are a great source of vitamin C and many birds enjoy them. Unfortunately, they have thousands of seeds.

We used only hand tools for our efforts to date. We will have to revisit this area and continue to remove and monitor our progress. Root removal may be the next step, but we would like to investigate other methods. This is the second step in a long process. **So keep tuned to our web page and the newsletter.**

Myrtle Point Park is a wonderful resource for many outdoor activities. Recently, the park has become host to a whole new group of outdoor enthusiasts, called geocachers. What is a geocacher you might ask? Geocaching is a worldwide high tech game of hide and seek. The only three things you need are a computer, a Global Positioning System (GPS) receiver and a spirit to go out there and hunt! The game is played by hiding a “geocache” like the ones found here in Myrtle Point, then going online and inputting its coordinates on a web site (www.geocaching.com). This web site is host to literally thousands of geocaches around the world. Other geocachers can log on to the site and find the page for the geocache, input the coordinates into their GPS receiver and go out and hunt. Geocaches can take many shapes, but they are usually clear plastic airtight containers. The container should have “Geocache” clearly marked on it and contain a logbook inside. The geocache can also contain trade items. These can be many types of dollar items and are sometimes part of a theme like pets, or toy cars, etc. The person finding the geocache can sign the logbook and chose to trade an item. Geocachers are strong advocates of “leave no trace” and often remove trash from the parks they visit. Geocache owners periodically check on their geocaches and make sure that they continue to provide enjoyment for those who visit. Geocaching is a fun family activity and a great way of enjoying the trails! Geocaches are often associated with area/park history or beautiful views such as those found here. Myrtle Point has proven to be an excellent location for that reason and because of the good trails and several different hikes to choose from. It is currently the home to five geocaches. So next time your out at the park and pass by someone pondering hiding places in the woods, know that it’s just a geocacher searching or looking for that perfect spot! - _ **Annual Cleanups:** Riverwide: Spring trash removal from designated sites.
